TERMS & CONDITIONS

NZD STAFF SAVER DIGITAL DISCOUNT CARD

- 1. To receive your staff rate, click on the 'Digital Staff Discount Card' link and follow the registration instructions. Once you are successfully registered, you will be able to use your discount.
- 2. Save your digital staff discount card on your phone for easy access and display the barcode screen, along with photo ID at any PlaceMakers or Mico store to receive a NZD Staff Saver Discount which is COST +5% +GST.
- 3. This offer is not valid in conjunction with any other promotional offer, clearance deal or purchases made with a GE Finance or GEM Visa card. Excludes purchases of Gift Cards and deliveries.
- 4. Offer is valid to a maximum purchase value of \$20,000 per annum between both PlaceMakers and Mico.
- 5. Any staff member who wishes to engage in a project involving building a house or purchasing materials for major renovations or alterations is required to submit a written request to the Branch Operator / Manager seeking prior authorisation.
- 6. Purchases must be paid in full at time of purchase via cash, EFTPOS or credit card. Deposits may be required on special order in items.

- 9. The NZD Staff Saver Digital Discount Card is available after three months service to full-time and permanent part time employees only (working 20 hours or more a week). Should you register beforehand, you will receive a notice stating that the digital staff card is 'temporarily unavailable', along with an indication of how many days before the card is active.
- 10. Access to the NZD Staff Saver Digital Discount Card will be suspended upon termination of employment.
- 11. This card and purchasing discount is a privilege and in the event that an employee breaches the terms and conditions stated above, the access to this digital staff card may be suspended immediately.

- 12. PlaceMakers and Mico reserve the right to cancel access to this digital card at any time without notice.
- 13. These terms are subject to change so please continue to check them periodically. Continuing to use your NZD Staff Saver Digital Discount Card will constitute acceptance of those amended terms and conditions.
